

**GTCOA Ballot for the Election of Five Directors 2026-2028 Term**  
**Must be received by GTCOA by January 1, 2026 - Please Vote!**

In accordance with our By-Laws, each year five Directors will be elected to represent the Membership. Each is elected to serve for a three year term. To be counted, Ballots must be received by us on or before January 1, 2026. We ask that you put your name and Membership Number on the back side of your ballot only to ensure that you are an eligible voter or nominator. All ballots will remain confidential and will be seen only by the counting committee. Space has been provided for write-in candidates. Write-in's will be viewed as nominations for future elections, provided it is done with the nominee's knowledge and approval, and eligibility as specified in Article VI of the Club By-Laws.

The five listed candidates have been given the endorsement of your Board of Directors. No other nominations have been received from the general Membership. These endorsed candidates were selected based on the Board's knowledge of the candidates and the Board's opinions as to who will best serve and represent the Membership.

**Vote for a total of 5 only.** Five candidates were nominated and voted on at the October 2025 Board of Directors meeting, for general membership consideration and voting. Any additional names nominated by the general membership will be discussed at the January 2026 Board Meeting for consideration in future elections or appointment but will **not** be considered for the current balloting.
